## Motorola Retirees Dental Insurance Head's Up

For those of you who are under 65 and still have Motorola Dental you may be interested in the experience I am going through on "major dental" insurance.

The first surprise that shouldn't have been a surprise was the coverage of my root canal. Since I haven't had major dental done in years, I had forgotten that the deductible has doubled to \$200 and major dental now covers at only 50%. So that's more than double what I would have paid in 2002 before the coverage change.

My bigger surprise came after finding that I would need an additional treatment to the root tips – called Apicoectomy. Upon getting my Motorola Explanation of Benefits, I had a significant portion not covered as it was over Motorola's "reasonable and customary" charge. I am being asked to pay the total for this difference. While I am trying to resolve this issue, I have several recommendations if you are having significant dental work or working with a new dentist where you don't have a track record.

- 1. Reread your 2003 dental plan in the 2003 U.S. Retiree Benefits Book.
- 2. Ask your dentist or specialist to do a "pretreatment estimate". They can do this via their normal electronic filing process to Motorola Insurance but they need to note it is for estimate and not a bill. You should get a copy of this.
- 3. If they won't do it for you, but they should, get the procedure names, billing codes and you can call or send in this yourself. They will only tell you if you are fully covered or over R&C (reasonable and customary) no specific numbers.
- 4. In either case above, I'd recommend trying to get a commitment from your dental office to honor R&C if any additional work is required while the procedure is in process.
- 1. Call around. Once I got the procedure codes for my operation, I called several other places. Some were similar to what I was charged, but the range in rates was over two to one. You may not just go to the lowest cost place, but you now have the basis to decide.

I would have saved a lot of time and probably money had I followed these recommendations to start with.


## The Executive Board Meeting, October 12, 2004




