Minutes of November 9, 2004, General Membership Meeting

The MLSRCT general membership meeting was held on November 9, 2004 at the Senior Activity Center. The meeting was called to order by the president, Danna Redford at 10:10 A.M.

Allan Alaspa moved that the treasurer's report be accepted as presented by Mike Temple; it was seconded by Jim Wilson, and subsequently approved.

Officer Election – Danna Redford presented the 2005 officers for approval. It was suggested that all be elected; the motion carried. They are as follows:

President – Danna Redford

Vice-President - Clarence Mehlow

Secretary – Frank Pribble

Treasurer – Mike Temple

Change from Motorola to Freescale - Danna presented the letters from the Phoenix Club and input from the Austin Club that has been sent to Ron Miller, Corporate Benefits office (Global Rewards) regarding issues and questions as to now being a Freescale retiree and how it now effects our health care benefits, etc.

Corporate will answer all the questions presented by the club that pertains to Motorola issues in the form of a letter sent to all US retirees. (Letter should have been received.)

Freescale will be responsible for answers pertaining to Freescale.

Consultations were held with lawyers regarding what our options, if any, would be regarding this change. Limits are spelled out in the plan documents, which is our contract. All plan documents would have to be reviewed and studied carefully.

Mike Temple reminded us that under the new privacy law, we no longer are provided a list from Motorola/Freescale of the retirees when they leave the company. The club has provided membership cards for the HR to give to the retirees. The club has received very few of these back. If you know of anyone who is a retiree or has the amount of years (5 years that we now require for membership) please pass on the club info to them.

The Executive Board Meeting, October 12, 2004

Attendees: Danna Redford, Brent Brown, Allan Alaspa, Clarence Mehlow, Louis Struble, Mike Temple, Betty Temple, Fred Thomas, Frank Pribble

Health Care Update: Mike Temple commented that he had received input from Phoenix retiree that he was unable to log in to Humana, concern was whether he was covered if he couldn't access his status online. Issue dealt with gaining approval of 3 month mail in prescription. Upon investigation, learned that Freescale has a list of names that database will not recognize as being covered.

Humana Web Site Accessibility: Danna also unsuccessful at logging on to view her account. The person she contacted from Humana stated the problem with the database should be fixed by January 18th. In addition, new medical cards are forthcoming due to inaccuracy in the ID numbering system. These issues should be cleared up in time for the newletter distribution.

Database Issues: Betty stated that medicare supplemented with Humana will not automatically show up in database. There may be similar issues for anyone who has medical payments transferred from pension or a checking account other than with the TruWest credit union. Betty pointed out that once newsletter is distributed with latest coverage information, it will help draw in new members who are looking for this type of information.

Hot Line: Mike Temple suggested that we establish a call committee so that we can contact everyone with new information. Must be able to reach our members who do not have email accounts. No decision taken.

Freescale H.R. Representation: Betty brought up need for having a Freescale H.R. representative present at the Board meetings to address any concerns. In addition, the Board would like to send one or more of our board representatives to any open H.R. Communication Meetings.

2005 Trip Schedule: Betty mentioned that she will be looking at upcoming trips for 2005. Two trips were cancelled last year due to insufficient participation. Trips are open to Motorola retirees and any others needed to make up the numbers. The Mississippi River trip is one trip that generated considerable interest initially.

Food: Betty brought up the need to plan for food at upcoming meetings. Several alternatives are restaurants, catering, and using the Freescale cafeteria. Betty and Danna to discuss offline.

Budget Line Items: Mike asked for any new budget line items. Printing and Postage was discussed as an additional item. We may be able to have Freescale help us with the expenses on this item, but we need to budget for it. There currently is a budget line item in the amount of \$250 annually for cost of speakers. This needs to cover a small gift for our guest speakers, too.

Sunshine Chairman: Betty felt very strongly that our Club should be expressing our sympathies to the families when there is a loss of one of our members. Also, a get well message for those with extended illness is also thoughtful to send from the Club. Danna to contact Pearl about her ability to do this.

Benefits Cross-Check - Freescale vs. Motorola: Allan reviewed the differences in benefits of both Freescale and Motorola Health plans. It appears that copays changed -- Motorola requires a flat \$30 while Freescale has a \$20/35 copay plan. On prescriptions, the Freescale plan is much better for generics, the same for preferred, and \$5 more for non-preferred mail order. On dental plans, using the Humana approved dentist can help reduce cost.

Action Items as follows:

- A. All Board members to try logging into the Humana System now and after the 18th of January. Report back findings and if there were any new issues.
- B. Allan will contact Dave Doolittle on concerns about medical coverage.
- C. Danna to investigate if Freescale will support the postage and printing costs of newsletter.
- E. Allan to present to Dave Doolittle series of questions on retiree status at Freescale; e.g., retiree badges, accessibility to inside the facilities, membership enrollment forms at separation for the former employee to join the Retiree Club.
- F. Brent to invite Dave Doolittle as speaker for the next meeting. (Allan will bring up prior to Brent making contact with Dave).
- G. Danna to find out how many folks the senior citizen center will hold. (150)
- H. Mike to follow up on Parmer Auditorium availability and cost for the meeting at which Dave will be speaker.
