#### **Benefit News**

Effective March 29 Freescale moved administration of it's benefits programs, including retiree medical, from the Rewards Administration Center (RAC) to the Freescale Rewards Customer Service Center (administered by Hewitt Associates).

You will receive your first invoice for any benefits you are enrolled in during the 4th week of April. Typically, your bills will mail around the 15th of each month with a due date of the 1st of the month. Due to the conversion, the invoices are being mailed late, so the due date will be extended for the first payment from May 1 to May 31.

You will receive additional information about the billing process and how to enroll in direct debit with your first bill. For any questions, please contact the Freescale Rewards Customer Service Center at 1.888.FSL.BENS or visit www.freescale.com/rewards.

As mentioned above, Hewitt will be mailing out this information (regarding transition), along with the billing process/enroll in direct debit to all retirees. Hewitt will also be adding the SPD (Summary Plan Document: description & summaries of your 2005 Freescale Rewards/Benefits for retirees) on their Hewitt website- available May 6th.

# Minutes of February 8, 2005, General Membership Meeting

We agreed to see if we could get the freescale Parmer Lane Auditorium for all future general membership meetings. (August and November are OK; May was already booked.)

Post Office Tour is scheduled for Feb 24th. Cost is \$30, which includes travel arrangements, tour, and lunch. Tour will be offered if there are a minimum of 25 participants.

Las Vegas trip is scheduled for three days - May 31 through June 2nd. Cost is \$273, which includes round trip airfare and 2 nights stay at the Imperial Palace hotel. Must know if you are interested within the next week in order to lock in the price quoted. Need minimum of 10 participants. Contact Betty Temple ASAP if you are interested in participating in either of the above tours.

Freescale/Motorola Retiree Club Update: David Doolittle has confirmed that Freescale will continue sponsorship of the Retiree Club and that former Freescale employees are welcome to join the Retiree Club. He also agreed to attend future Retiree Club executive committee meetings, representing Freescale and their relationship in terms of benefit coverage programs.

Business Update (by Dave): Discussion centered upon Motorola to Freescale transition milestones and the changes that took place in compensation, benefits, worklife, and line of sight accountability for current Freescale and former Motorola employees. The Freescale Benefits package was changed from fixed benefits/pension plan to rewards tied more directly to individual performance. Reward Programs that feature stock equity, incentive bonuses, and a generous 401K program were implemented to align more closely to competitive companies in the technology industry.

David Doolittle stated there is no current plan at Freescale to alter the benefits package provided for former Motorola employees.

Reyes Martinez' Update: Humana will manage Medical benefits. The Toll Free number for Humana is 1-800-992-5802. This number is located on the back of your medical insurance card. Dental benefits are also handled by Humana, but with a different phone number: 1-800-233-4013 (see the back of your dental card).

The correct Prescription Group number is J2859999. Call Humana if the number on your medical card is incorrect. They will issue you a new card with the correct number. Or just request a new card via the website.

If your insurance coverage was being deducted from your pension payment, Hewitt will implement in March 2005 a payment process for medical coverage to be auto deducted from personal checking and savings accounts. If your payment is not deducted from your TruWest credit union account, continue to send in monthly payments with your invoice statement until the change from Hewitt goes into effect. After the March statement, the Post Office Box will be changing, so you will need to send your payment to the new address specified in future correspondence from Hewitt.

If you are eligible for the Motorola Pension plan, the number to call in order for information is 1-800-585-5100 (the TIME number). Dial \*0 to speak directly to a representative.
