Minutes of August 14, 2007, General Membership Meeting

Meeting was called to order by Wayne Harned, president. Previous meeting minutes reviewed and approved, as was the Treasurer's report.

Membership - Jim Remedi reported the current club active membership holds at 167 members. Last year, there were 169 active members.

Holiday Dinner - Wayne Harned reported the dinner will be held again at Freda's on Dec. 4th. The signup sheet was made available at the meeting and will also be at the November general meeting.

Insurance Meeting - Review board members Jim Remedi, Stuart Hoyt, Jim Benneboese, and Mike Coley reported their findings:

a. Their focus was primarily on members falling into the pre-65 category, since post-65 are already covered in some manner through federal programs.

b. Some guidelines the board recommends is to choose your coverage wisely, the premiums charged by insurance companies can vary for identical coverage.

c. It is best to stick with "A" rated companies, who potentially have greater long-term stability.

d. For healthy individuals, the Group health insurance rates may be higher than the person can find for individual coverage, since the companies must cover high-risk members included in the group

e. Club members over 65 use Medicare as their primary health insurance plan. They can also apply for supplemental health insurance to cover expenses which Medicare does not cover.

f. Recommend a policy with \$5M lifetime maximum coverage.
