#### Minutes of November 13, 2007, General Membership Meeting

Meeting was called to order and the previous meeting minutes were approved.

Roger Countryman summarized the year to date balances in the club account. Highlights were \$3100 donated in scholarships, Austin Senior Center donation of \$100, \$589 for picnic, with \$22,026.01 in money market maximizer, and \$103.28 in credit union share account. Treasury report accepted as is by general membership present.

Jim reported 167 active members this year, 169 active members in 2006. Executive committee would like to increase the members 10-20% by adding recent retirees from Freescale. Badges are now available for those interested, will be coordinated with the Christmas Party.

Pat Gosman and Danna Redford are coordinating the list of attendees and selected menu items. Pat showed several of the door prizes that will be given away at Freda's Restaurant during the party.

Freescale Healthcare Update: Shawna Deshazo represented the Activity Center. and Barbara Gladden represented Aetna insurance benefits program.

2008 Executive Board Elections: There were no nominations for the Executive Board positions from the General Membership, so in order to keep the club ongoing, Officers and Board Members Wayne Harned agreed to continue as President, Jim Remedi stepped in as Vice President, Frank Pribble continues as Secretary, and Mike Coley may act as Treasurer – assuming the membership approves.

We got an e-mail from the Motorola retirees group in Florida saying that they were disbanding because they were unable to find people to hold the elected positions. Luckily, at the meeting to disband, volunteers came forward to fill the positions so they will not disband at this time. Our retirees club here in Austin needs to get more participation from the members or we run the same risk.

At the present time Wayne Harned is serving his second year as our president, Jim Remedi is the only vice-president at this time (with no agreement to take over as President next year), Frank Pribble has served three years as secretary, and we did not have a treasurer candidate at the election of officers meeting. However Mike Coley has volunteered to take the treasurer position. Also our committee chairs have served for multiple years, and we have several open slots with no one serving. I am sure that none of the members want anything like what almost happened in Florida to happen to our Austin retirees club. We need everyone's help to make our retirees club a success.

The board would like more participation from the members to fill any open committee chairman slots, serve on the committees, and suggestions from anyone on how we can get better member participation and new members.

# The Executive Board Meeting, January 8, 2008

The board meeting was held in the Parmer Lane Activity Center conference room. Present were Al Alaspa, Pat Gossman, Brent Brown, Jim Remedi, Mike Coley, Danna Redford, Wayne Harned, Roger Countryman, and Frank Pribble.

Mike Coley with Roger Countryman reviewed the actual 2007 expenses and budget for 2008. The Year-end 2007 budget/actual report was approved by Wayne Harned and Roger Countryman.

At the last General Membership meeting, there were no nominations for Club treasurer. In order to keep the Club functioning, Committee Chairperson Mike Coley will step in as Treasurer for 2008, pending approval of the membership at the next General Meeting. After this is done, Mike will present the budget for 2008.

Roger Countryman, Wayne Harned, and Mike Coley will notify the Credit Union of changes to the Executive Board so that financial transactions can occur under the new Treasurer.

It was reported that there were a couple of inputs from members on what they would like to see presented at the General Membership meetings, mostly focused around financial programs and medical insurance benefits. The Board will continue to arrange speakers on those topics on a periodic basis. Jim Remedi will follow up with the insurance advisory committee.

The discussion of lack of sponsorship by Freescale has led to a decision to discontinue the

scholarship program. Instead, the Board proposes to donate to a charitable cause, using the annual interest earned of approximately \$750 from the Club money market account. The Board recommends a "short list" of non-profit organizations to include Big Brother/Big Sister, Hospice, Safe Place (Center for Battered Women). Wayne will present the Board proposal at the next General Membership meeting.

Pat Gosmon will take a look at offering a Vegas trip for Members and report back to the Board on her findings.

The 2008 Club membership dues are now due. The Board decided that, beginning in 2008, the dues will not be pro-rated.
