Speaker: Tom Starnes, former Motorola Engineer (among other things)

A year after graduating from UT as an electrical engineer, Tom's career got its bearings when he joined Motorola as a marketing engineer in the (then) young microcomponents operation in Austin. There was much to learn about the 6800 family, and many people from whom to learn. Soon he was focused on the high-end 68000 microprocessor. He honed many skills making and giving presentations, writing articles, visiting customers, and bringing feedback to the chip architects. He also learned a great deal about business. He spent two years working in Europe. His last two years at Motorola were in digital signal processor (DSP) marketing.

After 17 years, Tom joined the market research firm Dataquest (which was soon bought by Gartner) where he was an industry analyst covering Embedded Processors (MPUs, MCUs, and DSPs). This broadened his view well beyond Motorola, giving him insight into all of the companies building processor chips, their products, applications, and strategies. He went to even more trade shows, mostly semiconductor vendor visits, building a trust with hundreds of personal contacts, and writing numerous reports analyzing and enumerating the industry. He came across many ex-Motorolans in other companies, held discussions with CEOs and executives, and advised hundreds of marketers, PR people, and news people. This includes former arch-rival Intel.

Twelve years later, Tom (who had stayed in Austin, a pioneer in the working-remote/work-from-home trend) left Gartner and continued as an industry analyst, incorporating ghost-writing and high-tech consulting into the role and starting his own company, Strategy Sanity.

Throughout Tom's career, relationships with people have been paramount. They often dribbled into his personal life. A company is made up of people and is a reflection of the energy, ideas, and personalities of those people.

GENERAL MEETING, August 10, 2021

Attendees: The ZOOM general meeting was called to order at 10:05AM by Sandra Lawell with +/-25 members and guests in attendance.

Welcome: President Sandra Lawell welcomed everyone in attendance and then our guest speaker was introduced by Norman Herr.

<u>Guest Speaker:</u> Clay Cowan is an estate planning, probate and federal tax law/ planning attorney, as well as a CPA. These skills combined are important since many of the decisions we make have tax implications.

Earlier Norman Herr provided verbiage to differentiate between a financial planner and an estate planner which is included here: The key distinction is that estate planning is typically directed by an estate planning attorney rather than a financial planner. Estate planning also includes elements beyond financial assets, including who can make health care decisions on your behalf, open your mail, care for your pets, etc.

Mr. Cowan's presentation included some of the following: Wills, Beneficiary Designations, Revocable Living Trust, Durable & Medical Power of Attorney and Directive of Physician. The presentation was followed by Q&A. For more information, a video is available, and additionally Mr. Cowan provided his power point presentation.

<u>Treasurer Report:</u> Cal Gooden displayed the treasurer's report: Income: \$315 collected in Dues since May (65 members have paid dues); \$605 in scholarship donations and \$0.19 in Interest. The club balance is \$10,780.83. No expenses were incurred. The Scholarship funds show a balance of \$2640.52 (\$2500 budget). The MAAC scholarship amount is reflected/deposited in the savings account.
