Speaker: Paul Yura, Warning Coordination Meteorologist of the National Weather Service for Austin /San Antonio.

Paul Yura was born and raised in Austin TX and received his Bachelor of Science degree in meteorology from the University of Oklahoma. He joined the National Weather Service in 1992 and has worked as a meteorologist and forecaster in Norman, Oklahoma, Brownsville Texas, and Charleston, South Carolina. Paul became a Warning Coordination Meteorologist in 2002 and has worked at the Austin-San Antonio National Weather Service Office since 2008. Paul's primary job is to be the liaison between the National Weather Service and local media, citizens, county, state, and federal agencies. He conducts storm damage surveys and leads the community outreach program.
